#### **REPORTS**

#### **President's Report**

Each month the Instructional Division will provide a report entitled Professional/Scholarly/Service Activities which will highlight faculty members and their accomplishments. These reports are provided to the trustees and will be made a part of the public record.

#### Red Bud Workforce Development Project

SWIC staff began meeting in February with representatives of the City of Red Bud and Red Bud area industries. Members of the local community approached college staff for assistance in developing and attracting a greater pool of workforce candidates for the local industries.

Led by Vice President Clay Baitman, the college team included Selsius Director Lynette Rienbolt; Dean of Technical Education Programs Brad Sparks; and Campus Executive Director and Associate Dean for Instructional Services Mike Reed. The team has met with community representatives on three occasions to assess the needs and services the college is able to provide.

The project is focusing on five action plans addressing three primary issues of concern, to be completed jointly by Southwestern Illinois College and the City of Red Bud:

- 1. Expand the geographic pool of potential job applicants.
- 2. Explore offering a short sequence of technical education classes designed to teach a set of generic, entry-level employee skills common to the majority of industries in the community.
- 3. Identify customized training needs to meet the requirements of higher level skills in these industries.

#### Air Force Community Partnership Initiative

Dr. Janet Fontenot, Dean of the Business Division, is participating in the newly formed cybersecurity working group as part of the Air Force P4 Initiative. The purpose of this group is to develop new and to strengthen existing partnerships between the military and local community resources in the field of cybersecurity. Members will be conducting a gap analysis to explore the current and future needs of a cybersecurity workforce to support Scott AFB and the region.

Dr. Fontenot and Matt Swinford, coordinator for SWIC's Network Design and Administration program, also met with Colonel Michael Harasimowicz, Commander of the 688 Information Operations Wing at Joint Base San Antonio, to explore SWIC's potential role in providing cybersecurity training.

#### **High School Computer Contest**

Nine local high schools brought 115 students to the Belleville Campus on April 10 to participate in the 23<sup>rd</sup> Annual High School Computer Contest. The 25 teams represented Belleville East, Belleville West, Chester, Edwardsville, Mascoutah, New Athens, O'Fallon, Red Bud, and Waterloo high schools. Students competed in the areas of Computer Programming, Software Applications and Web Design.

#### Allsup Elevator Pitch Competition

The Allsup Elevator Pitch Competition was held April 15 in the Liberal Arts Complex on the Belleville Campus. This year 154 students from seven area high schools submitted business plans for new products or services. Twenty students were selected to present an elevator pitch on their idea in front of an audience of fellow students, parents, and teachers. A panel of three judges selected five students with the best ideas and presentations to receive cash prizes of \$500 each. This is the fifth year for this event; and it is fully funded by Jim Allsup and Roger Lowery of Northwestern Mutual Financial Network.

### **SWIC Scholarships Update**

#### Belleville Campus

Participants throughout the United States are paid to tour nationally accredited centers that exemplify quality in the classroom. Four individuals also flew in from Brazil to research opening a similar center. The tour focused on curriculum display boards, room arrangement, lesson plans, learning centers and interactions between staff and children.

# College Activities

College Activities presented George Portz and the Friends of Bluegrass to a sold out crowd on March 27. Theatre goers were treated to the latest installment of the longest running Collegiate Bluegrass Festival in the Nation.

#### Theatre Club

The Theatre Club opened their SWIC-tacular Showcase on April 10. Performers showcased their talents to fellow students along with the presentation of several student films and two short one-act plays.

#### Red Bud Campus

During Spring Break eight Red Bud Campus Phi Theta Kappa and College Activities Board members, along with Community Services Coordinator Amy Brockman and PTK Advisor Krista Olson, joined SWGCC PTK members on a trip to New Orleans, LA to volunteer at the St. Bernard Parish home building project site.

Red Bud Campus College Activities and Phi Theta Kappa Beta Iota Iota held their fifth Annual Trivia Night on March 28. The event raised \$1,562 with the proceeds helping fund the Phi Theta Kappa/College Activities Alternative Spring Break and PTK Beta Iota Iota scholarship.

Red Bud Campus College Activities and Phi Theta Kappa Beta Iota Iota hosted Sweet Week on April 13-16 to help fund the St. Bernard Alternative Spring Break trip.

The Red Bud Campus College Activities Poetry Contest 2015 entry deadline was February 27; there were 243 entries. Judges have chosen first, second and third place winners in seven different categories. The Awards Ceremony will be held April 21.

#### **Granite City Campus**

# **Community Services and Campus Operations**

The second annual Senior Art Competition was held March 26 – April 9 on the Belleville Campus in the Liberal Arts Conference Room. Fifty eight seniors submitted a total of 106 pieces of art viewed by approximately 350 persons attending the exhibit. Special thanks to the 34 RSVP volunteers who manned the exhibit during those dates. Next year's Senior Art Competition and exhibit will be held March 3 - 7 in the Schmidt Art Center.

#### Red Bud Campus

More than 165 high school students, along with teachers and parents from Monroe, Randolph, and St. Clair Counties, attended the tenth Annual Transitional Fair sponsored by Perandoe, the Illinois Department of Human Services, and Southwestern Illinois College at the Red Bud Campus on March 20. Students had an opportunity to see the campus and receive advice and resources from the 43 different participating agencies.
