Dear Deputy or Officer:

You have been accepted into the Southwestern Illinois Police Academy.

Please read the following information regarding the P.O.W.E.R. Test carefully. **If you have not started your online pre-registration process, get started NOW!**

PARKING

Parking is available on the south side of the campus in parking lot M5. You should park in the **PARKING LANE FACING SIDEWALK DIVIDER BETWEEN LOT M5 and M4**. See attached Belleville Campus Map.

P.O.W.E.R. TEST

Tuesday, July 23, 2019, 8:00 a.m. has been scheduled for physical fitness testing. You must pass the P.O.W.E.R. test to remain eligible to attend the academy.

1. Be in Room 1515 **before 8:00 a.m.**
2. Firearms will not be carried or brought on campus unless requested or permitted by the academy staff or the range master.

The physical fitness test will be administered at 8:00 a.m. sharp. Recruits who **do not** have a completed medical form on file, (this is the physical fitness exam form) or with them the morning of the testing **CAN NOT** be tested and **WILL NOT** be admitted to the academy. **No one will be admitted to the Academy that fails to arrive on time for this test. You may wear the following clothing for the physical fitness test (locker room facilities will be available):**

1. Short sleeve, athletic T-shirt
2. Athletic shorts (must have on during "sit and reach" exercise) (knees must be clearly visible)
3. Hooded sweatshirt and sweatpants (if necessary) or other clothing as weather dictates, **YOU SHOULD PLAN ON RUNNING OUTSIDE.**
4. Athletic socks
5. Running shoes

DRESS CODE FOR THE POLCIE ACADEMY

The following dress code will be adhered to throughout the training session:

1. Department issued uniform shirt, long or short sleeve, with collar, buttoned down the front. No polo shirts. If you do not have a uniform, a long sleeve dress shirt, with collar, buttoning all the way down the front and tie.
2. Department issued uniform pants/trousers. If uniform is not available bring dress trousers (i.e., cotton, corduroy, etc.) **No Jeans of any type.**
3. Plain black or dark brown socks.
4. Department issued shoes or boots; black or brown walking shoes, dress shoes, or uniform style tennis shoes (no sport type tennis shoes or western style boots).
5. Departmental uniform should be worn **as soon as it becomes available**. Officers will be told when the uniform should not be worn due to the nature of the training being conducted. **Officers staying "away from home" during the academy should maintain both a set of "civilian" business attire clothing as well as a set of dress-down clothes to facilitate changes in the dress code.**

Police Academy classes begin on Monday, August 5, 2019.

An officer will be considered absent even if present, when he/she is unable to perform or participate in the classes scheduled activities. Absences in excess of 40 hours will result in dismissal from the academy.

10. **Department squad car if possible should be provided for defensive driving and traffic stop procedures. (Recruits will be notified of the exact dates when they receive their schedule)**
11. Copies of the following forms should be sent with the recruit officer.
 - A. Photo copy of department's Notice to Appear form.
 - B. 60 **photocopies** of department's traffic citations
 - C. 5 photocopies of department's misdemeanor complaint form
 - D. 1 photocopy of department written Miranda form
 - E. 1 photocopy of department's field sobriety report form
 - F. 1 photocopy of department's domestic violence report

(Your department may not utilize all of the above-mentioned reports and forms. Bring with you the reports and forms your department does use.)
