CALL TO ORDER

A special meeting/public hearing of the Board of Trustees of Southwestern Illinois College, District No 522 was held Monday, December 28, 2015 in the Mildred Feurer Hall of PSOP, 201 North Church Street, Belleville, Illinois. Chairman Nick Mance called the meeting to order at 5:00 p.m.

PUBLIC HEARING

A public hearing was held concerning the proposed 2015 tax levy in accordance with the Illinois Truth-in-Taxation law. Chairman Mance asked SWIC Controller Missy Roche to state the reasons for the proposed tax levy increase.

Ms. Roche stated in order to continue eligibility for ICCB Equalization Funding, the District must keep the operating tax rate at 95% of the Maximum Operating Rate as established by the ICCB. The second factor impacting the District is the upcoming final payment on the 2010 Working Cash Bond issue. The reduction in bond and interest payments in FY 2017 would cause a decrease in the tax levy, resulting in a decrease of over \$2.0M in tax levy extension.

Chairman Mance asked if anyone wished to offer comments in favor of the proposal; if anyone wished to offer comments against the proposal; or if anyone wished to submit comments in writing for or against the proposal. No comments, either verbal or written, were received.

Mr. Joseph moved, seconded by Mr. Morton, to close the public hearing. Upon a voice vote, the motion **PASSED**.

Nays: None. Absent: Ms. Stellhorn (Opinion), Mr. Smith, and Mr. Verdu. **PASSED**
