CALL TO ORDER

A meeting of the Board of Trustees of Southwestern Illinois College, District No. 522 was held Monday, March 30, 2015 in the Marsh Conference Room at the Belleville Campus, 2500 Carlyle Avenue, Belleville, Illinois. Chairman Nick Mance called the meeting to order at 5:05 p.m.

PLANNING AND POLICY COMMITTEE REPORT

Chairman Joseph reported he had no additional items.

FACILITIES AND FINANCE COMMITTEE REPORT

Dr. Briggs began discussion concerning the proposed tuition increase and stated this is a very difficult issue, but it is something that has to be done. "We have to continue looking at the integrity of the college and that of Instruction. We do everything we can to cut expenses. I am comfortable with the fact that we are trying to reduce our budget and operations and trying to predict state funding. I question if \$3 a credit hour is enough? I hate tuition increases and it is especially hard in my district."

Peer institutions smaller than SWIC have recently increased their tuitions. John A. Logan raised their tuition \$10/credit hour, and Kaskaskia College raised their tuition \$12/credit hour.

Trustee Verdu voiced his concern about the drop in enrollment. "We spend a lot of money on marketing. The Foundation does a good job in offering scholarships. I wish we could do more. I wish there was some study or way we could gauge if we are going to continue to lose students because of the tuition increases. There are three other institutions in our near vicinity. I also wish we could make it more clear about our hiring practices concerning the 6% SURS issues."

Dr. Costello stated she would hate to think where we would be without Marketing. "What they do on such a miniscule amount of money is amazing. They receive less than half of 1% of the budget."

Chairman Mance stated, "The issue comes down to this: the Board of Trustees has always been very conservative. The trustees are cognizant of tuition, tax rates, levies, etc. If you look deep down in the financial statements the columns are about even. If you don't stay ahead of the

curve, you at some point will have to have a large increase in tuition. It is difficult to go out in the district and ask for \$8 at one time. It is easier to ask for small amounts several times than one large amount at one time.”

Dr. Costello quoted that SWIC has the 27th lowest tuition in the state out of 48 community colleges. Vice President Fleming stated that \$1 of the proposed \$3 tuition increase will cover the WiFi costs, which 74% of SWIC students have requested.

Chairman Mance thought the \$3 per credit hour increase is enough right now and will look at a possible increase in the fall or next spring semester. Trustee Roehrkaske offered that at the time the budget comes to the Board of Trustees we should look at tuition at the same time. There was consensus from the trustees.

MOTION 03-30-15:02

Dr. Briggs moved, seconded by Mr. Verdu, to approve \$3 per credit hour tuition increase effective summer semester 2015. Upon a roll call vote, those trustees voting aye were Dr. Briggs, Mr. Joseph, Mr. Morton, Mr. Roehrkaske, Mr. Smith, Mr. Verdu and Mr. Mance. Nays: None. Absent: Mr. Raftopoulos (Opinion). **PASSED**

Poetry Out Loud

Area high school students recently took part in the Poetry Out Loud competition held at the Schmidt Art Center. Students from five local high schools (Alton, Edwardsville, Freeburg, Gibault, & Sparta) memorized and recited their poems out loud, with the winners moving on to the state, and possibly national competition. Sarah Lantsberger from Gibault was the champion, and Malec Caudell from Freeburg was the runner-up. The competition was co-sponsored by the Illinois Arts Council and the National Endowment for the Arts.

Belleville Campus College Activities

Many activities were sponsored by the Office of College Activities in honor of Black History Month. The climax of the month was an African dancing and drumming demonstration from the Sunshine Cultural Arts Center.

The International Student Club in partnership with the College Activities Board hosted a Chinese New Year celebration in the LAC. Students were treated to traditional Chinese food and had their fortunes told by the year of their birth.

Over 60 student leaders from three campuses gathered for a Leadership Summit on March 7. Students were able to hone their leadership skills with workshops on building effective teams, business etiquette and avoiding student burn-out.

SWGCC College Activities

Collected \$325 for the Siteman Cancer Center for the World Cancer Day Pinwheel sales; and on February 11th collected non-perishable food items for local food pantries.

ESLCCC College Activities

SWIC at the East St. Louis Community College Center Campus took 37 students and a guest to the Griot Museum of Black History and for a luncheon at The Choice Restaurant on February 28. The Griot Museum is only the second of its kind in the U.S., spotlighting notable African-Americans who were born in St. Louis or impacted the St. Louis region in arts & entertainment, politics & government, or business.

Red Bud College Activities

RBC College Activities and the American Red Cross hosted a blood drive on March 3 at the Red Bud Campus. Nineteen units of blood were collected.

Red Bud Campus College Activities will again host the Sweet Week Fundraiser. College Activities Board members will sell sweets April 13-16 in an effort to raise money to help fund Alternative Spring Break and Phi Theta Kappa Beta Iota Iota Scholarship.

Veterans & Career Services

Five student veterans attended the Student Veterans Leadership Day at the Illinois State Museum in Springfield, Illinois on February 25. The students attended sessions on legislative/governmental leadership, entrepreneurial/business leadership, and community leadership.

The Veterans & Career Services hosted a Job Fair at the Red Bud Campus on March 4. A total of 23 employers and 45 job seekers attended the Fair.

ICCTA Report

Trustee Roehrkaske attended the March meeting held in Naperville, Illinois and provided a copy the ICCTA Board Highlights from that meeting. The ICCTA Board of Representatives adopted a motion concerning baccalaureate degree-granting authority at Illinois community colleges. The ICCTA Government Relations and Public Policy Committee directed ICCTA to engage in another study with input from all segments of higher education and to produce a report to present by November 1, 2015. The vote was 30-1 with SWIC being the lone no vote.

The next meeting of the ICCTA Board of Representatives will be held April 28-29, 2015 in Springfield, Illinois in conjunction with Lobby Day on April 29. Mr. Roehrkaske plans to attend.
