

**Thank you for choosing the online Driver's Safety Class at Southwestern Illinois College!**

This course offers a friendly convenient way to complete the court ordered supervision for your traffic citation and can be taken from any computer equipped with a high-speed Internet connection and sound.

The course fee is \$45. The preferred method of payment is with a credit or debit card on the site at the time of enrollment. Visa, MasterCard, and American Express are accepted. Processing your payment by credit or debit card will allow you to pay and start immediately.

Upon check clearance we will enroll you in the course and notify you so you may immediately begin the course.

**Must use a laptop or computer; no smartphones or tablets.**

1. Be sure to have a copy of your ticket handy. You will need to provide your ticket number, date of issuance and county of issuance prior to starting the course.
2. Go to <https://trafficsafety.gatefeed.com/swic>
3. **New Users:** Create account by clicking on the 'click here to Register' link in the yellow post-it note or below the 'Login' button.

4. On the Registration page, fill out the required fields and click 'Submit'.
5. Select your course from the drop-down menu on the right side of the page and click 'Enroll'.
6. Next you will be on the payment page. Fill out the required fields and click 'Place Order'. You may print your receipt now or later if you wish.
7. To begin the course, click 'Return to Dashboard'.
8. Under 'My Courses', click 'Start Course'.
9. Enter your ticket information. This information will appear on your certificate that you submit to the courthouse, so make sure it is accurate! Click 'Submit'.
10. You may now begin your course by clicking the 'Start' button next to Step 1, Lesson 1.

## **About the Course:**

This four-hour course satisfies the requirements for Court-ordered supervision for Illinois drivers under the age of 21 who have received a traffic citation. Topics include the Illinois Graduated Drivers License law as well as youthful behaviors and external factors that contribute to dangerous driving situations. Emphasis is placed on anticipating, recognizing, and preparing for difficult situations and on accepting the responsibilities of safe driving.

\* The course consists of 4 steps, and each step is broken down into smaller lessons; with each lesson lasting approximately 10-15 minutes.

\* With the exception of the Final Test, you may log in and out of the course, however it is recommended that you complete the lesson you are on prior to logging out or you will have to re-take that particular lesson.

\*The course is narrated, so please make sure you have your computer volume on.

\*Once the narration on each slide finishes, a 'Next' button appears in the bottom, right-hand corner, which you must click to advance to the next slide.

\*At the end of each lesson (with the exception of Step 4, Lesson 2) there are 'Test Your Knowledge' questions that quiz you on the material you just learned. These questions do **NOT** count against you, but you may see them or similar questions again on the Final Test.

\*Once you complete the 4<sup>th</sup> step, there is a Final Test you must pass. The Final Test consists of 50 questions and you must receive 70% or higher to pass. You **CANNOT** log in and out of the Final Test. Once you begin, you must complete it.

\*After you pass the Final Test, a 'Download Certificate' button appears above 'Step 1, Lesson 1' on your Dashboard.

You may access your certificate at any time if you cannot immediately print it.

**\*\*\*Do not forget to turn in your certificate to the courthouse by your deadline!**
