MAP GRANT VERIFICATION FORM- *INDEPENDENT*

ISAC rules for the MAP grant include a requirement that you are an Illinois resident and have lived in Illinois since August 19, 2022. To be considered an Illinois resident, Illinois must be your true, fixed and permanent home.

If you answered YES, above, YOU MUST ALSO PROVIDE one of the following at this time as documentation of your Illinois residency in order to be considered for eligibility for a MAP grant award for the 2023-2024 financial aid year:

- **PREFERRED method of documentation: Provide a signed, nonreturnable copy of your 2022 Illinois state tax return (2022 Form IL-1040). If you filed as a part-year resident, you must also submit a copy of the Illinois Schedule NR that you filed with your return.**
- A copy of your 2022 IRS Form 1099-Miscellaneous Income Statement that shows your Illinois address.
- A copy of your Illinois driver's license issued **prior** to and **valid** on 8-19-2022.
- A copy of your State of Illinois identification card issued **prior** to and **valid** on 8-19-2022.
- An Illinois high school transcript or transcript from an ISAC-approved college or university, showing continuous attendance from 08-2022 to 05-2023.
- Copies of utility bills, rent receipts, or residential leases in your name showing that you lived at an Illinois address from 8-19-2022 through 8-19-2023 or to current date.
- Statement of benefits history from the Illinois Department of Healthcare and Family Services showing you received benefits from 08-19-2022 through 8-19-2023 or to current date.
- Statement of benefits from the Illinois Department of Employment Security showing you received benefits from 8-19-2022 through 8-19-2023 or to current date.
- Statement of benefits from the Social Security Administration showing you received benefits from 8-19-2022 through 8-19-2023 or to current date, and that shows your Illinois address.
- A copy of your Illinois auto registration card, in your name, issued **prior** to 8-19-2022.
- A copy of your 2022 Illinois property tax bill.
- A copy of your Illinois voter's registration card issued prior to 8-19-2022 but within the last three years.
