### **DRESS CODE**

The following dress code will be adhered to throughout the training session:

1. **Classroom Lecture.** Department issued uniform. If uniform is not available wear dress trousers (i.e., cotton, corduroy, etc.) and a collared shirt. No jeans of any type.
2. **Firearms Range.** Trousers with belt loops (BDU's, cargo pants, jeans), baseball style hat, body armor.
3. **Control Tactics.** Trousers with belt loops (BDU's, cargo pants, jeans)

### **ITEMS TO BRING FOR FIREARMS TRAINING:**

1. Center-fire duty handgun (dept. approved).
2. Three magazines.
3. Duty belt system (inner & outer belts).
4. Duty belt keepers.
5. Strong-side duty holster.
6. Double magazine pouch.
7. Baseball type cap.
8. Eye & ear protection equipment.
9. Police type "c" or "d" cell flashlight.
10. "MFT & Use of Force" manuals.
11. Ammunition (Academy issued).
12. Firearm cleaning & maintenance kit.
13. Outerwear for weather conditions.
14. Individual body armor.

### **ITEMS TO BRING FOR CLASSROOM LECTURE:**

1. Laptop computer, recommended, but not required
2. Appropriate classroom items. (Notebook paper, pens, pencils, highlighters etc.)

**SPECIAL NOTE:** Any missed class sessions or part thereof, as a result of illness or injury will result in the recruit being docked the time missed and will be listed as hours absent. An officer will be considered absent even if present, when he/she is unable to perform or participate in the classes scheduled activities. Absences in excess of 20 hours will result in dismissal from the academy.
