Preparation Points for each course will average: -1 point or > on a scale of Negative 2 to 0. Will track for trends, when noted as below threshold.

Oral Communication Points for each course will average: 0 points or > on a scale of Negative 1 to Positive 1. Will track for trends, when noted as below threshold.

Overall Assessment of Treatment Points for each course will average: 0 points or > on a scale of Negative 1 to Positive 1. Will track for trends, when noted as below threshold.

Written Communication/Documentation Points for each course will average: 0 points or > on a scale of Negative 1 to Positive 1. Will track for trends, when noted as below threshold.

Critical Indicator/Safety Concern deductions of 5 points or > will equate to less than 20% of the total enrollment, for each course. Nature of concerns will be tracked for trends.

Efficiency deductions of 5 points or > will equate to less than 20% of the total enrollment, for each course. Areas of efficiency deficits will be tracked for trends.

Contraindication deductions of 5 points or > will equate to less than 20% of the total enrollment, for each course. Nature of concerns will be tracked for trends. (Impacts PTA 151

Practical Examination Retake Attempts required of each course will be no more than 20% of the total class enrollment. Will track for trends.

All items met threshold by the terminal didactic experiences in PTA 201 and 211 Finals. The items highlighted for being slightly below threshold coorelate with expected areas of minor deficiency. Overall assessment of Rx has been emphasized in subsequent semesters in an attempt to improve numbers in this area in 2021-2022 reporting cycle. CAPTE review held in SU2020 proved that the program is meeting/exceeding expectations.
