CALL TO ORDER

Chairman Raftopoulos called the meeting to order at 5:58 p.m.

INFORMATION TECHNOLOGY HIGHLIGHTS

Chief Information Officer Linda Andres provided the following:

Trustee Campo asked who controls the college website and what is the feedback concerning the website. Chief Enrollment Development and Institutional Planning Officer Tebbe stated ownership is shifting from IT to Marketing, although IT is involved. Conversations revolve around "can we fix it or can we prepare a new one that is an enrollment driving model". He added that President Mance, CIO Andres and he have intense conversations concerning the project; there are a lot of layers to the website. CIO Andres continued with the charter is three-fourths complete and the group is working through all the issues. The expected timeline is 12-18 months.

Trustee Tippett questioned if the new website will contain 'fly-thru' areas so that students can see the campuses and areas. Mr. Tebbe and Ms. Andres replied a lot of the virtual tours are already completed.

Trustee Campo inquired of any student issues with Wi-Fi, technology, etc. they expressed in a survey. Officer Tebbe stated the response to the Campus Climate Survey was very low, which is not atypical. Faculty member Brett Egger offered to distribute surveys to students to obtain a better response. CIO Andres in response to Trustee Campo's question replied that bandwidth has doubled in all areas, some quadrupled; access points are not sufficient although 30 new access points were just added at the Belleville Campus and will next be installed at the Sam Wolf Granite City Campus.
