Monthly Marketing Report Admissions, Recruitment, & Outreach Monthly Activity Report

Enrollment for Summer 2024 is up at just over a 7% increase; and we are looking at an 8% enrollment increase for Fall 2024.

Trustee Campo requested an electronic advertising billboard/interactive video board at SWIC West. He realizes it is a huge cost upfront, but paid advertising would capture some of the cost. CFO Wheeler stated the cost would be an approved expense under the Southwestern Illinois Justice and Workforce Development Campus state funds. Chief Enrollment Development Officer Tebbe reported the Marketing team/committee is focusing on internal signage and directional wayfaring signs, along with a simplified map. The group meets weekly and more information will be provided.
